2. Is registered with Pakistan Telecommunication Authority;
3. Has submitted Rs. 10,000/- as the bid security in form of a PO/CDR/DD/BC in favor of Punjab Education Foundation as per bid security Rule of PPRA Rules 2014 (Amended till date) which states that a procuring agency may require the bidders to furnish a bid security not exceeding five per cent of the estimated price of procurement by the Procuring Agency.
4. Is providing cellular telephone and data services in all districts / tehsils of Punjab;
5. Has not been blacklisted by any of Provincial or Federal Government Department, Agency, Organization or Autonomous Body or Private Sector Organization anywhere in Pakistan.
6. Has purchased Bidding Document from the office of undersigned upon a cash payment of Rs. 500/- (nonrefundable).

Note: Verifiable documentary proof for all above requirements is mandatory, noncompliance will lead to disqualification.
